6. Committee Reports

a. Operations

Larry Peck noted that the key requirement is to find another person to help out in this area.

Follow up from last year, the geothermal work has not been done as there was a logistical issue.

It does function but not to peak level. Suggestions were offered of possible person to contact for this work. Also the cover over the electrical controls to raise and lower the basketball hoop at front of the gym is yet to be applied. This will be done.

b. Entertainment & Marketing

Melanie Gaines presented the report for this committee (attached) with recognition of a successful year with support from the board as well as community volunteers.

c. Financial

Peggy Warren reviewed the July 2014 to July 2015 fiscal year financial statements. The financial review was prepared by accountants Cowland & Associates and will be posted on the Saturna Recreation Centre Society website. It was noted that this is not an audited statement. At this point the SRC Society is in a good financial position thanks to successful fundraisers as well as donations. Currently SRCS has MOUs with the Saturna Community Club for the Medical Clinic, with Parks Canada and the Saturna Island Fire Protection Society. As well there are leases with School District 64 for use of the gym and with the CRD for use of the mezzanine area.

Motion by Linda Cunningham, to continue using Cowland & Associates accountants. **Carried**

President's Report – December 6th, 2015 AGM

This last year the Rec Centre has focused on its core strengths, and it has proved to be a successful year on many levels.

The Rec Centre's primary core strength revolves around the hard-working, knowledgeable and enthusiastic volunteers that create and keep the energy around the events we host and the facility that hosts them. This includes the board, the entertainment committee and all the other people who created the successes we had in the past year.

Pickleball has continued to build on its first-year success and has a dedicated following, and we've introduced many more to the sport in this past year. Our fitness centre has expanded its equipment roster, adding an elliptical machine, pilates machine and another treadmill.

We are proud to continue our support of community organizations like the SEEC school, SIMRES, the Lions Club, the bridge group and many others. Our island is the envy of other island communities with having facilities like the Rec Centre and the Community Hall, allowing us to host so many different types of events, in uniquely tailored spaces.

Our hosting of tried-and-true events turned out to be a successful formula, with attendance up across the board. And our one special event – the Founders' and Friends' Celebration - was a smashing hit. Much of this was due yet again to the efforts of community members – decorating the Rec Centre ceiling with hundreds of feet of tulle fabric and twinkling lights. And of course the meal was exceptional, with Hubertus and a cast of hard-working helpers plating, bussing, washing (by hand!) for the sold-out event. This was a community fund-raising event and by every measure it was

a stunning achievement, reflecting the immense generosity of Saturna Islanders in support of their community amenities.

In other areas the Rec Centre continues as a member of the Gulf Islands Trails Society (GITS), whose objective is to pro-actively encourage trail development on private land and, particularly, to improve access to public trails. As well as providing signage and trail maintenance, GITS carries liability insurance for trails on private property. And the croquet club (who received a small financial contribution from the Rec Centre) continues to grow. The Rec Centre also provided a small contribution to the Cine-club, to assist their efforts at bringing fine cinema to our island.

So we are wrapping up a fine year with just a couple events yet to deliver - tree-lighting and the New Year's dinner and dance. The dinner, featuring cuisine by chef Hubertus has already sold out and the dance, with music by the well-known and highly acclaimed Lebeau-Peterson band will almost certainly rock the Rec Centre like never before.

I am honoured to work with the Rec Centre board and others in helping to make Saturna an active, healthy and fun place to live and visit.
